IPCC forms International Expert Panel to facilitate its Study on recent Public Order Events

(Hong Kong – August 23, 2019) The Independent Police Complaints Council (IPCC), at its special in-house meeting held earlier (16 August), has decided to extend the scope of its fact-finding study (the "Study") on the large-scale Public Order Events (POEs) beyond 2 July and publish its findings in phases.

Dr Anthony Francis Neoh, QC, SC, JP, Chairman of the IPCC stated that, "The Study will be in three steps: 1) Fact Finding; 2) Assessment; and 3) Recommendations. The IPCC is now inviting overseas experts to form an International Expert Panel (the "Panel") and has contacted scholars and specialists from oversight bodies in the United Kingdom, Australia, New Zealand and Canada. The invitees have extensive experiences in researching crowd behaviour and public order, studying public order events and police actions. To ensure the objectivity of the Study, the Panel will participate in the Assessment and the subsequent Recommendations work for IPCC's consideration. The list of Panel Members will be announced in due course."

As of 22 August, the IPCC has received over 1,300 submissions containing more than 25,000 texts, photos, video clips and hyperlinks. A total of 183 Reportable Complaints and 273 Notifiable Complaints stemming from the POEs (refer to Annex for latest complaint figures) were received. 95 observations have been completed by Observers to ensure all interviews and collection of evidence related to the Reportable Complaints conducted by CAPO have been carried out on a fair and impartial basis, achieving 100% attendance rate. Since early July, the Council has also published and regularly updated the latest figures of complaints and related classifications of allegations on its website for public and media viewing.

The Steering Group, comprising Chairmen of Serious Complaints Committee (SCC), Operations Advisory Committee (OAC), Publicity and Survey Committee (PSC) and Legal Committee (LC) and the Special Task Force also visited the Police Tactical Unit Headquarters last week and observed a demonstration of the equipment and weapons used by Anti-riot Police officers when they are in operation. The IPCC will continue to follow up and request the Police to provide the principles and guidelines

for using these weapons.
