- (iii) If, during an open meeting, No. 8 or higher Tropical Cyclone Warning is hoisted, or Black Rainstorm Warning or an "Extreme Condition" announcement is issued, or it is known that a No. 8 or higher Tropical Cyclone Warning Signal, a Black Rainstorm Warning or an "Extreme Condition" announcement will be issued soon, the Member presiding at the meeting would decide whether to adjourn or continue with the meeting.
- (iv) The Member presiding at the meeting would decide whether to adjourn or continue with the meeting if other unforeseen circumstances arise.
